- **Deployment and Training:** Deployment of vans to local healthcare centers and training of drivers and maintenance personnel from the local communities.
- **Sustainability Support:** Regular servicing and collaboration with local NGOs and government health programs for operational sustainability.
- **Geographical Focus:** The project will primarily serve rural and underserved areas within the identified states.
